WHEREAS, the TWG, during the September 30, 2015 meeting of the BAC-EP, reported its validation and confirmation of the legal, technical and financial requirements submitted by EC Structural Composites, Inc.;

NOW, THEREFORE, We the members of the Bids and Awards Committee, hereby RESOLVED as it is RESOLVED:
