**"A RESOLUTION DECLARING YSL BUILDERS AS THE SINGLE CALCULATED  
BIDDER FOR THE PROJECT REPAIR AND MAINTENANCE OF PORT PHYSICAL  
FACILITIES PROJECT PACKAGE II-2015, PORT OF GENERAL SANTOS"**

**WHEREAS**, THE Philippine Ports Authority (PPA), PMO SOCSARGEN posted/published the Invitation to Bid for the project Repair and Maintenance of Port Physical Facilities Project Package II-2015, Port of General Santos, Makar Wharf, General Santos City with an Approved Budget for the Contract (ABC) of **One Million Two Hundred Thirty Three Thousand Two Hundred Ten Pesos and 57/100 (Php1,233,210.57)** only;

**WHEREAS**, the said Invitation to Bid was posted at the PhilGEPS, PPA Websites and at the PMO SOCSARGEN's Bulletin Board;
