"A RESOLUTION DECLARING KHAN KON CHI CONSTRUCTION AS THE SINGLE CALCULATED BIDDER FOR THE PROJECT REPAIR OF DAMAGE SETTLED CONCRETE PAVEMENT BETWEEN ACCESS ROAD OF CYS II AND III, PORT OF GENERAL SANTOS"

WHEREAS, the Philippine Ports Authority (PPA), PMO-SOCSARGEN published the Invitation to Bid for the project Repair of Damage Settled Concrete Pavement Between Access Road of CYS II and III, Port of General Santos with an Approved Budget for the Contract (ABC) of Three Million Six Hundred Twenty Three Thousand Nine Hundred Thirty Seven Pesos and Seventy Eight Centavos(Php 3, 623, 937.78);

WHEREAS, the said Invitation to Bid was posted at the PHILGEPS, PPA Websites and the PMO-SOCSARGEN Bulletin Board;

WHEREAS, in addition to the said publication and posting requirement and to encourage participation from more bidders, letters of invitation were sent to prospective bidders;

WHEREAS, in response to the said publication and posting, only one (1) bidder, Khan Kon Chi Construction, purchased and submitted its bids within the deadline set last 29 December 2014 at 9:00 A.M;

WHEREAS, upon opening of eligibility, technical and financial proposal, Khan Kon Chi Construction passed the complete documentary requirement, to wit:

- b) To direct the Technical Working Group to conduct Post Qualification on December 6-8, 2014.
