**PORT TERMINAL MANAGEMENT CONTRACT FOR THE BASEPORT – ILOILO
COMMERCIAL PORT COMPLEX**
BAC-PTMC-07-2023

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the PTMC for Baseport – Iloilo Commercial Port Complex (ICPC) in newspaper of general circulation, PPA website and in conspicuous places in the PPA premises on 21 December 2023;

WHEREAS, the Minimum Fixed Concession Fee for Years 6 to 10 of the PTMC as posted is Php 500,000,000.00;

WHEREAS, in response to the said advertisement, International Container Terminal Services, Inc. (ICTSI) secured the Bid Documents in the amount of Php 150,000.00;

WHEREAS, during the deadline for submission of bids, ICTSI dropped its Technical and Financial Bids on time;

WHEREAS, ICTSI's Technical Bid was declared "Passed" during the Opening of Bids on 11 January 2024;


WHEREAS, ICTSI's Financial Bid was opened and declared "Passed" at its Proposed Concession Fee of Php 750,000,000.00 exclusive of all taxes;

WHEREAS, Bid Evaluation was conducted to determine compliance with the requirements of PPA Administrative Order (AO) No. 12-2018 and the Bid Evaluation Report was approved by the BAC-PTMC on 22 January 2024, declaring ICTSI at its Proposed Concession Fee for Years 6 to 10 of Seven Hundred Fifty Million Pesos (Php 750,000,000.00) exclusive of all taxes as the Single Responsive Bid;

WHEREAS, Post-Qualification was conducted on 25 January 2024 and conditions for eligibility and the bidding; and in the Post-Qualification Report, as approved by the BAC-PTMC on 26 January 2024, the proposal of ICTSI was declared as the Single Responsive Bid;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC-PTMC hereby RESOLVE, as it is hereby RESOLVED, to declare ICTSI at its Proposed Concession Fee for Years 6 to 10 of Seven Hundred Fifty Million Pesos (Php 750,000,000.00) exclusive of all taxes, as the Single Responsive Bid and to recommend the award of Port Terminal Management Contract for the Baseport – ICPC.
