Award of Contract for the

IMPROVEMENT/RESTORATION OF RC PLATFORM, RORO RAMP NO. 1, BACK-UP AREA, RETAINING WALL, PASSENGER TERMINAL BUILDING, FENCE AND GATE, PORT OF PIO DURAN, ALBAY

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Improvement/Restoration of RC Platform, RoRo Ramp No. 1, Back-Up Area, Retaining Wall, Passenger Terminal Building, Fence and Gate, Port of Pio Duran, Albay, in the websites of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 08 December 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 31,681,572.53**;

WHEREAS, in response to the said advertisement, three (3) bidders secured the Bid Documents in the amount of \$\mathbb{P}\$25,000.00 and submitted their Technical and Financial Proposals, namely:

- 1. ARKY Construction and Supply
- 2. Mancol Construction Corporation
- 3. E.U. Jingco Construction Corp./Big J Steel Construction Corp./JV

WHEREAS, during the opening of bids on 19 January 2024 at 9:00 a.m., only Mancol Construction Corporation and E.U. Jingco Construction Corp./Big J Steel Construction Corp./JV were declared "passing" with the requirements of the First Envelope. ARKY Construction and Supply was declared "failed" with the requirements of the Technical Proposal, for the following reasons:

- a. Failed to meet the required experience for the Supply and Install 50-100 kg/pc Core Rocks and 1000 kg/pc Armour Rocks. There was no weight per piece indicated in the submitted supporting documents.
- Failed to include the one (1) unit Concrete Cutter in the Bid Form for the Statement of the Bidder's Equipment pledged for the contract to be Bid.

WHEREAS, ARKY Construction and Supply signified its intention to file a request for reconsideration, hence, the unopened Second Envelope was retained by the BAC, until the request for reconsideration has been resolved by the Committee;

WHEREAS, the Financial Proposal of Mancol Construction Corporation and E.U. Jingco Construction Corp./Big J Steel Construction Corp./JV were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 17 January 2024 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 18 January 2024, showed deviations in the Bid Proposal of E.U. Jingco Construction Corp./Big J Steel Construction Corp./JV. The quantity used for Bill No. 4.03 is 279.10 cu.m. instead of 279.51 cu.m., as specified in the BOQ. Section 32.2.1 (a) of the 2016 Revised IRR of R.A. 9184, provides that:

"Completeness of the bid. Unless the Instructions to Bidders specifically allow partial bids, bids not addressing or providing all of the required items in the Bidding Documents including, where applicable, bill of quantities, shall be considered non-responsive and, thus, automatically disqualified xxx."

WHEREAS, E.U. Jingco Construction Corp./Big J Steel Construction Corp./JV was declared automatically disqualified for failure to conform to the required quantity in the Bill of Quantities;

WHEREAS, Mancol Construction Corporation was declared as the Single Calculated Bidder in the amount of ₱ 31,427,858.72;

WHEREAS, post-qualification was conducted on 20 January 2024 to examine, validate and verify the eligibility, technical and financial requirements submitted by Mancol Construction Corporation and in the Post-Qualification Report, as approved by the BAC on 24 January 2024, Mancol Construction Corporation was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED, to declare **MANCOL CONSTRUCTION CORPORATION** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Improvement/Restoration of RC Platform, RoRo Ramp No. 1, Back-Up Area, Retaining Wall, Passenger Terminal Building, Fence and Gate, Port of Pio Duran, Albay, in the amount of **THIRTY ONE MILLION FOUR HUNDRED TWENTY SEVEN THOUSAND EIGHT HUNDRED FIFTY EIGHT PESOS AND 72/100 (Php 31,427,858.72)**, inclusive of taxes, to the said bidder.
