Award of Contract for the
RESTORATION OF PAVEMENT, PORT OF CALAPAN, ORIENTAL MINDORO
HO-INFRA-PPDD-23-0067

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Restoration of Pavement, Port of Calapan, Oriental Mindoro, in the websites of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 08 December 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 30,800,839.58**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents in the amount of ₱ 25,000.00 and submitted their Technical and Financial Proposals, namely:

1. Orient Star Construction, Inc.
2. ARKY Construction and Supply

WHEREAS, during the opening of bids on 15 January 2024 at 2:00 p.m., only Orient Star Construction, Inc. was declared "passing" with the requirements of the First Envelope. ARKY Construction and Supply was declared "failed" for failure to meet the required experience for the Supply and Install 50-100 kg/pc Core Rocks and Supply and Install Concrete Blocks. The weight per piece of the Core Rocks cannot be verified as it is not indicated in the submitted supporting documents. Likewise, they submitted 80 pcs instead of 83 cu.m. for the Concrete Blocks;

WHEREAS, ARKY Construction and Supply signified its intention to file a request for reconsideration, hence, the unopened Second Envelope was retained by the BAC, until the request for reconsideration has been resolved by the Committee;

WHEREAS, the Financial Proposal of Orient Star Construction, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, ARKY Construction and Supply filed its request for reconsideration on their "failed" rating, and in a meeting held on 18 January 2024, the BAC, after due deliberation, denied the request for reconsideration;

WHEREAS, Bid Evaluation was conducted on 17 January 2024 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 18 January 2024, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Orient Star Construction, Inc.;

WHEREAS, Orient Star Construction, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 30,700,034.18;

WHEREAS, post-qualification was conducted on 20 to 22 January 2024 to examine, validate and verify the eligibility, technical and financial requirements submitted by Orient Star Construction, Inc. and in the Post-Qualification Report, as approved by the BAC on 24 January 2024, Orient Star Construction, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED, to declare **ORIENT STAR CONSTRUCTION, INC.** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Restoration of Pavement, Port of Calapan, Oriental Mindoro, in the amount of **THIRTY MILLION SEVEN HUNDRED THOUSAND THIRTY FOUR PESOS AND 18/100 (Php 30,700,034.18)**, inclusive of taxes, to the said bidder.
