PROPOSED CONSTRUCTION AND OFFSHORE INSTALLATION OF AIDS TO MARINE NAVIGATION IN NORTHERN MINDANAO: PORTS OF SURIGAO AND LIPATA, SURIGAO CITY; SAN JOSE, DINAGAT ISLAND; DAPA, SIARGAO ISLAND; NASIPIT AND MASAO, BUTUAN CITY; BALINGOAN, MISAMIS ORIENTAL

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Proposed Construction and Offshore Installation of Aids to Marine Navigation in Northern Mindanao: Ports of Surigao and Lipata, Surigao City; San Jose, Dinagat Island; Dapa, Siargao Island; Nasipit and Masao, Butuan City; Balingoan, Misamis Oriental, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 20 December 2022, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 445,406,783.47**;

WHEREAS, in response to the said advertisement, three (3) bidders secured the Bid Documents in the amount of \$\bigsip\$ 50,000.00 and submitted their Technical and Financial Proposals, namely:

- 1. Jarzoe Builders, Inc.
- 2. MAC Builders
- 3. Hi-Tone Construction and Development Corporation

WHEREAS, during the opening of bids on 11 January 2023 at 10:00 a.m., the three (3) bidders were declared "passing" with the requirements of the First Envelope.

WHEREAS, the Financial Proposal of the three (3) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 18 January 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 19 January 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Jarzoe Builders, Inc. and MAC Builders;

WHEREAS, deviation was found on the Bid Proposal of Hi-Tone Construction and Development Corporation, hence was declared "automatically disqualified," pursuant to Section 32.2.1 (a) of the 2016 Revised IRR of R.A. 9184, which provides, to wit:

"Completeness of the bid. xxx, bids not addressing or providing all of the required items in the Bidding Documents including, where applicable, bill of quantities, shall be considered non-responsive and, thus, automatically disqualified xxx."

WHEREAS, Jarzoe Builders, Inc. was declared as the Lowest Calculated Bidder in the amount of ₱ 444,897,142.87;

WHEREAS, post-qualification was conducted on 27 January 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Jarzoe Builders, Inc. and in the Post-Qualification Report, as approved by the BAC on 01 February 2023, Jarzoe Builders, Inc. was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **JARZOE BUILDERS INC.** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Proposed Construction and Offshore Installation of Aids to Marine Navigation in Northern Mindanao: Ports of Surigao and Lipata, Surigao City; San Jose, Dinagat Island; Dapa, Siargao Island; Nasipit and Masao, Butuan City; Balingoan, Misamis Oriental, in the amount of **FOUR HUNDRED FORTY FOUR MILLION EIGHT HUNDRED NINETY SEVEN THOUSAND ONE HUNDRED FORTY TWO PESOS AND 87/100 (P 444,897,142.87)**, inclusive of taxes, to the said bidder.
