Award of Contract for the

PROJECT: PORTS OF DAPITAN, SINDANGAN AND LILOY,
ZAMBOANGA DEL NORTE**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Proposed Dredging of Northwestern Mindanao Clustered Project: Ports of Dapitan, Sindangan and Liloy, Zamboanga del Norte, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 06 December 2024, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 115,704,569.01**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents in the amount of ₱ 50,000.00, namely:

1. WTG Construction and Development Corporation
2. ESR Construction and Development Corporation

WHEREAS, only WTG Construction and Development Corporation dropped its Technical and Financial Proposals, before the prescribed deadline for submission of bid documents. ESR Construction and Development Corporation did not submit their Technical and Financial Proposals, nor submitted a letter of withdrawal from participating in the bidding before the prescribed deadline for submission of bid documents;

WHEREAS, during the opening of bids on 16 January 2025 at 9:00 a.m., WTG Construction and Development Corporation was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of WTG Construction and Development Corporation was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 20 January 2025 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 21 January 2025, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of WTG Construction and Development Corporation;

WHEREAS, WTG Construction and Development Corporation was declared as the Single Calculated Bidder in the amount of ₱ 115,152,147.50;

WHEREAS, post-qualification was conducted on 25 January 2025 to examine, validate and verify the eligibility, technical and financial requirements submitted by WTG Construction and Development Corporation and in the Post-Qualification Report, as approved by the BAC on 28 January 2025, WTG Construction and Development Corporation was declared as the Single Calculated and Responsive Bidder;


NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare, **WTG CONSTRUCTION AND DEVELOPMENT CORPORATION** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Proposed Dredging of Northwestern Mindanao Clustered Project: Ports of Dapitan, Sindangan and Liloy, Zamboanga del Norte, in the amount of **ONE HUNDRED FIFTEEN MILLION ONE HUNDRED FIFTY TWO THOUSAND ONE HUNDRED FORTY SEVEN PESOS AND 50/100 (₱ 115,152,147.50)**, inclusive of taxes, to the said bidder.
