WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Three (3) Units Large Format Multifunctional Printer/Copier/Scanner System, in the websites of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 13 December 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 8,000,000.00**;

WHEREAS, in response to the said advertisement, only Functional, Inc. secured the Bid Document in the amount of ₱ 10,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 17 January 2024 at 2:00 p.m. Functional, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Functional, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 18 January 2024 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 18 January 2024, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Functional, Inc.;

WHEREAS, Functional, Inc. was declared as the Single Calculated Bidder in the amount of **₱ 7,844,500.00**;

WHEREAS, post-qualification was conducted on 29 January 2024 to examine, validate and verify the eligibility, technical and financial requirements submitted by Functional, Inc. and in the Post-Qualification Report, as approved by the BAC on 02 February 2024, Functional, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **FUNCTIONAL, INC.** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Procurement of Three (3) Units Large Format Multifunctional Printer/Copier/Scanner System, in the amount of **SEVEN MILLION EIGHT HUNDRED FORTY FOUR THOUSAND FIVE HUNDRED PESOS (PHP 7,844,500.00)**, inclusive of taxes, to the said bidder.
