WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Proposed Dredging of Iloilo Clustered Project: Iloilo River, International Container Port Complex (ICPC), Fort San Pedro, Dumangas and Jordan, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 20 December 2022, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 250,037,158.17**;

WHEREAS, in response to the said advertisement, five (5) bidders secured the Bid Documents in the amount of 50,000.00 and submitted their Technical and Financial Proposals, namely:

- 1. WTG Construction and Development Corporation
- 2. MAC Builders
- 3. Sunwest, Incorporated
- 4. Khan Kon Chi Construction and Development Corporation
- 5. Hi-Tone Construction and Development Corporation

WHEREAS, during the opening of bids on 11 January 2023 at 2:00 p.m., the five (5) bidders were declared "passing" with the requirements of the First Envelope.

WHEREAS, the Financial Proposal of the five (5) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 18 January 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 19 January 2023, showed discrepancies between the Total Bid Prices and Unit Bid Prices of WTG Construction and Development Corporation, Sunwest, Incorporated and Hi-Tone Construction and Development Corporation;

WHEREAS, post-qualification was conducted on 21 & 24 January 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Khan Kon Chi Construction and Development Corporation and in the Post-Qualification Report, as approved by the BAC on 08 February 2023, Khan Kon Chi Construction and Development Corporation was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare KHAN KON CHI CONSTRUCTION AND DEVELOPMENT CORPORATION as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Proposed Dredging of Iloilo Clustered Project: Iloilo River, International Container Port Complex (ICPC), Fort San Pedro, Dumangas and Jordan, in the amount of TWO HUNDRED FORTY EIGHT MILLION FIVE HUNDRED THIRTY ONE THOUSAND ONE HUNDRED FORTY EIGHT PESOS AND 75/100 (₱ 248,531,148.75), inclusive of taxes, to the said bidder.
