Award of Contract for the UPGRADING, EXPANSION AND CONSTRUCTION OF POB (PHASE I), PORT OF LILOAN, SOUTHERN LEYTE

LFP ELS NO. 020-2022

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Upgrading, Expansion and Construction of POB (Phase I), Port of Liloan, Southern Leyte, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 22 December 2022, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 381,397,811.71**;

WHEREAS, in response to the said advertisement, four (4) bidders secured the Bid Documents in the amount of ₱ 50,000.00, namely:

- 1. Octagon Concrete Solutions
- Hi-Tone Construction and Development Corporation/ Khan Kon Chi Construction and Development Corporation/JV
- 3. Sunwest, Incorporated
- 4. Vicente T. Lao Construction

WHEREAS, only three (3) bidders dropped their Technical and Financial Proposals on the scheduled date of the opening of bids. Vicente T. Lao Construction submitted its letter of withdrawal, dated 18 January 2023, from participating in the bidding, and the BAC, finding the reasons to be meritorious, accepted its withdrawal from participating in the bidding;

WHEREAS, during the opening of bids on 18 January 2023 at 10:00 a.m., the three (3) bidders were declared "passing" with the requirements of the First Envelope.

WHEREAS, the Financial Proposal of the three (3) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 24 January 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 25 January 2023, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Sunwest, Incorporated and Hi-Tone Construction and Development Corporation/Khan Kon Chi Construction and Development Corporation/JV, as follows;

WHEREAS, Hi-Tone Construction and Development Corporation/Khan Kon Chi Construction and Development Corporation/JV was declared as the Lowest Calculated Bidder in the amount of \$\mathbb{P}\$ 379,887,713.43;

WHEREAS, post-qualification was conducted on 01, 02 & 04 February 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Hi-Tone Construction and Development Corporation/Khan Kon Chi Construction and Development Corporation/JV and in the Post-Qualification Report, as approved by the BAC on 08 February 2023, Hi-Tone Construction and Development Corporation/Khan Kon Chi Construction and Development Corporation/JV was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare HI-TONE CONSTRUCTION AND DEVELOPMENT CORPORATION/KHAN KON CHI CONSTRUCTION AND DEVELOPMENT CORPORATION/JV as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Upgrading, Expansion and Construction of POB (Phase I), Port of Liloan, Southern Leyte, in the amount of THREE HUNDRED SEVENTY NINE MILLION EIGHT HUNDRED EIGHTY SEVEN THOUSAND SEVEN HUNDRED THIRTEEN PESOS AND 43/100 (₱ 379,887,713.43), inclusive of taxes, to the said bidder.
