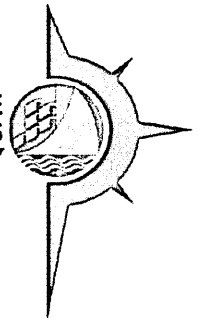

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery & Installation of Materials, Furniture & Fixtures for the Renovation of Legal Services Department, in the websites of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 13 December 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 6,755,082.69**;

WHEREAS, in response to the said advertisement, only Global Konstruction & Development Corporation secured the Bid Document in the amount of ₱ 10,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 16 January 2024 at 2:00 p.m. Global Konstruction & Development Corporation was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Global Konstruction & Development Corporation was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:



WHEREAS, Global Konstruction & Development Corporation was declared as the Single Calculated Bidder in the amount of **₱ 6,750,672.10**;

WHEREAS, post-qualification was conducted on 29 January 2024 to examine, validate and verify the eligibility, technical and financial requirements submitted by Global Konstruction & Development Corporation and in the Post-Qualification Report, as approved by the BAC on 02 February 2024, Global Konstruction & Development Corporation was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **GLOBAL KONSTRUCTION & DEVELOPMENT CORPORATION** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply, Delivery & Installation of Materials, Furniture & Fixtures for the Renovation of Legal Services Department, in the amount of **SIX MILLION SEVEN HUNDRED FIFTY THOUSAND SIX HUNDRED SEVENTY TWO PESOS AND 10/100 (PHP 6,750,672.10)**, inclusive of taxes, to the said bidder.

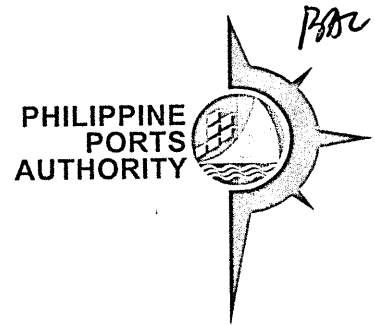
