**Award of Contract**

**FOR THE PROCUREMENT OF SERVICES OF CERTIFYING BODY  
FOR THE QUALITY MANAGEMENT SYSTEM OF PPA**

WHEREAS, the Philippine Ports Authority (PPA) posted a Request for Proposal (RFP) for the Procurement of Goods and Consultancy Services (BAC-PGCS) for the Procurement of Services of Certifying Body for the Quality Management System of PPA, under Negotiated Procurement (Two-failed Biddings), pursuant to Sections 53, 54 and Annex "H" Consolidated Guidelines for the Alternative Methods of Procurement of the 2016 Revised IRR of RA 9184, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 15 December 2021, continuously for three (3) calendar days;

WHEREAS, the BAC-PGCS, likewise invited five (5) certifying bodies who are technically, legally and financially capable for negotiation to ensure effective competition, as follows:

1. SOCOTEC Certification Philippines, Inc.
2. TUV Nord
3. SGS Philippines, Inc.
4. TUV Rheinland, Philippines
5. Certification International Philippines, Inc.

WHEREAS, the Approved Budget for the Contract (ABC) is **₱ 3,800,000.00**;

WHEREAS, three (3) certifying bodies responded to the invitation and submitted its proposal, together with all the required technical and financial documents, namely;

1. SOCOTEC Certification Philippines, Inc.
2. TUV Rheinland, Philippines
3. Certification International Philippines, Inc.

WHEREAS, during the Negotiation held on 28 December 2021, the prospective certifying bodies were given the opportunity to negotiate and discuss the technical and financial requirements of the project to be able to submit a responsive quotation or proposal, except for Certification International Philippines, Inc. where no representative attended the Negotiation;

WHEREAS, during the evaluation of the Technical and Financial requirements conducted for the Project, only SOCOTEC Certification Philippines, Inc. passed the Technical and Financial requirements while TUV Rheinland Philippines, Inc. was declared as failed. Certification International Philippines, Inc. failed to comply with the submission of the required documents;

WHEREAS, SOCOTEC Certification Philippines, Inc. submitted its best offer based on the final technical and financial requirements, in the amount of **P2,830,800.00**;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend, for approval of the Head of the Procuring Entity, the award of contract for the Procurement of Services of Certifying Body for the Quality Management System of PPA to **SOCOTEC CERTIFICATION PHILIPPINES, INC.**, in the amount of **TWO MILLION EIGHT HUNDRED THIRTY THOUSAND EIGHT HUNDRED PESOS (P2,830,800.00)**.
