WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Forty (40) Units Automated External Defibrillator (AED), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 23 December 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is ₱ 10,000,000.00;

WHEREAS, in response to the said advertisement, only BT Industries, Inc. secured and submitted the Bid Documents;

WHEREAS, during the opening of bids on 21 January 2020 at 2:00 p.m., BT Industries, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of BT Industries, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 23 January 2020 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 24 January 2020, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of BT Industries, Inc.;

WHEREAS, BT Industries, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 9,920,000.00;

WHEREAS, post-qualification was conducted on 29 January 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by BT Industries, Inc. and in the Post-Qualification Report, as approved by the BAC on 05 February 2020, BT Industries, Inc. was declared as the Single Calculated and Responsive Bidder;



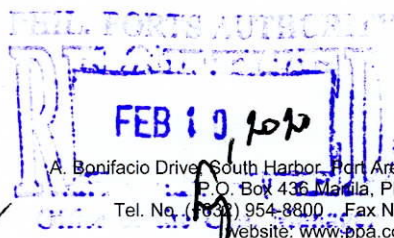
