WHEREAS, the Philippine Ports Authority (PPA) advertised an Invitation to Bid for the Procurement of Six (6) Units of Vehicle X-Ray Machines for RoRo Ports, in the Manila Standard, a newspaper of general nationwide circulation on 27 November 2017 and posted the same in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as published/advertised is **₱ 750,000,000.00**;

WHEREAS, in response to the said advertisement, five (5) prospective bidders secured Bid Documents in the amount of ₱ 75,000.00, namely:

1. Astrophysics, Inc./Astrophysics Asia, Inc./Genesis Transunited, Inc./JV
2. S&S Enterprises, Inc./Tec Sen Co. LTD/JV
3. Metro Mobilia Corp./Guandong Binggong Security Equipment Co. LTD/JV
4. Arktek System Builders, Inc./Safeway Inspection System Limited/JV
5. Green Trust Medical Trading

WHEREAS, only three (3) bidders dropped their Technical and Financial Proposals, namely: Astrophysics, Inc./Astrophysics Asia, Inc./Genesis Transunited, Inc./JV; S&S Enterprises, Inc./Tec Sen Co. LTD/JV and Metro Mobilia Corp./Guandong Binggong Security Equipment Co. LTD/JV. Arktek System Builders, Inc./Safeway Inspection System Limited/JV and Green Trust Medical Trading did not submit their bid documents nor submitted a letter of withdrawal from participating in the bidding before the deadline for submission of bids;

WHEREAS, during the opening of bids on 07 February 2018 at 10:00 a.m., only S&S Enterprises, Inc./Tec Sen Co. LTD/JV was declared "passing" with the requirements of the First Envelope. Astrophysics, Inc./Astrophysics Asia, Inc./Genesis Transunited, Inc./JV and Metro Mobilia Corp./Guandong Binggong Security Equipment Co. LTD/JV were declared "failed;"

WHEREAS, both Astrophysics, Inc./Astrophysics Asia, Inc./Genesis Transunited, Inc./JV and Metro Mobilia Corp./Guandong Binggong Security Equipment Co. LTD/JV signified their intentions to file their requests for reconsideration, however only Astrophysics, Inc./ Astrophysics Asia, Inc./Genesis Transunited, Inc./JV submitted their request within the prescribed deadline for filing thereof;

WHEREAS, the BAC, in a meeting held on 14 February 2018, after due deliberation on the request for reconsideration of Astrophysics, Inc./ Astrophysics Asia, Inc./Genesis Transunited, Inc./JV denied said request for reconsideration;

WHEREAS, the Financial Proposal of S&S Enterprises, Inc./Tec Sen Co. LTD/JV was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 13 February 2018 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 14 February 2018, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of S&S Enterprises, Inc./Tec Sen Co. LTD/JV;

WHEREAS, S&S Enterprises, Inc./Tec Sen Co. LTD/JV was declared as the Single Calculated Bidder in the amount of ₱ 748,488,000.00;

WHEREAS, post-qualification was conducted on 16 February 2018 to examine, validate and verify the eligibility, technical and financial requirements submitted by S&S Enterprises, Inc./Tec Sen Co. LTD/JV and in the Post-Qualification Report, as approved by the BAC on 20 February 2018, S&S Enterprises, Inc./Tec Sen Co. LTD/JV was declared as the Single Calculated and Responsive Bidder;

WHEREAS, Astrophysics, Inc./ Astrophysics Asia, Inc./Genesis Transunited, Inc./JV submitted another Motion for Reconsideration dated 26 February 2018, instead of filing a protest pursuant to Section 55 (Protests on Decisions of the BAC) of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **S&S ENTERPRISES, INCORPORATED/TEC SEN COMPANY LIMITED/JOINT VENTURE** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Procurement of Six (6) Units of Vehicle X-Ray Machines for RoRo Ports, in the amount of **SEVEN HUNDRED FORTY EIGHT MILLION FOUR HUNDRED EIGHTY EIGHT THOUSAND PESOS (₱ 748,488,000.00)**, inclusive of taxes, to the said bidder.
