WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery and Installation of a Corporate Anti-Virus with Hybrid Network Support for Two (2) Years at the PPA Head Office and Port Management Offices Nationwide, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 06 February 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 7,500,000.00**;

WHEREAS, in response to the said advertisement, three (3) bidders secured the Bid Documents in the amount of ₱ 10,000.00 and submitted their Technical and Financial Proposals, namely;

- 1. Itraverse Solutions, Inc.
- 2. Macrologic Diversified Technologies, Inc.
- 3. Accel Prime Technologies, Inc.

WHEREAS, during the opening of bids on 28 February 2023 at 10:00 a.m. Macrologic Diversified Technologies, Inc. and Accel Prime Technologies, Inc. were declared "passing" with the requirements of the First Envelope, while Itraverse Solutions, Inc. was declared "failed" for failure to submit an updated PhilGEPS Registration Platinum Membership Certificate with the current and valid Mayor's Permit as indicated in Annex "A" Eligibility Documents;

WHEREAS, Itraverse Solutions, Inc. signified its intention to file a request for reconsideration on its "failed" rating, hence, the unopened Second Envelopes were retained by the BAC, until the request for reconsideration has been resolved by the Committee:

WHEREAS, the Financial Proposals of the two (2) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, on 01 March 2023, Itraverse Solutions, Inc. filed a request for reconsideration on their "failed" rating, however, the BAC, in a meeting held on 07 March 2023, after due deliberation and upon motion duly made and properly seconded, denied said Request for Reconsideration;

WHEREAS, Bid Evaluation was conducted on 06 March 2023 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 07 March 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Macrologic Diversified Technologies, Inc. and Accel Prime Technologies, Inc.;

WHEREAS, Macrologic Diversified Technologies, Inc. was declared as the Lowest Calculated Bidder in the amount of ₱ 6,334,120.00;

WHEREAS, post-qualification was conducted on 14 March 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Macrologic Diversified Technologies, Inc. and in the Post-Qualification Report, as approved by the BAC on 16 March 2023, Macrologic Diversified Technologies, Inc. was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **MACROLOGIC DIVERSIFIED TECHNOLOGIES, INC.** as the Lowest Calculated and Responsive Bidder, and to recommend the award of contract for the Supply, Delivery and Installation of a Corporate Anti-Virus with Hybrid Network Support for Two (2) Years at the PPA Head Office and Port Management Offices Nationwide, in the amount of **SIX MILLION THREE HUNDRED THIRTY FOUR THOUSAND ONE HUNDRED TWENTY PESOS** (**PHP 6,334,120.00**), inclusive of taxes, to the said bidder.
