Award of Contract for the  
**DREDGING OF CURRIMAO PORT, CURRIMAO, ILOCOS NORTE**  
LFP NLZ NO. 002-2022

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Dredging of Currimao Port, Currimao, Ilocos Norte, in the website of the PPA, PhilGEPs and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 05 February 2022, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 117,212,929.20**;

WHEREAS, in response to the said advertisement, four (4) bidders secured the Bid Documents in the amount of **₱ 50,000.00** and submitted their Technical and Financial Proposals, namely;

1. WTG Construction and Development Corp.
2. KXBG Construction and Development Corp./Kenzai Builders Corp./JV
3. Hi-Tone Construction and Development Corp.
4. Sunwest Construction and Development Corp.

WHEREAS, during the opening of bids on 24 February 2022 at 2:00 p.m., only three (3) bidders were declared "passing" with the requirements of the First Envelope. WTG Construction and Development Corp. was declared "failed" for failure to submit the updated PhilGEPs Certificate of Registration Platinum Membership;

WHEREAS, WTG Construction and Development Corp. signified no intention to file a request for reconsideration, hence, they were notified that their unopened Second Envelope will be returned by the BAC;

WHEREAS, the Financial Proposals of the three (3) bidders were opened. Sunwest Construction and Development Corp. was declared "automatically disqualified" for submitting its Financial Proposals which are not book-bound as required under Item 6 of Bid Data Sheet. The financial bids of the two (2) bidders namely: KXBG Construction and Development Corp./Kenzai Builders Corp./JV and Hi-Tone Construction and Development Corp. were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 03 March 2022 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 04 March 2022, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Hi-Tone Construction and Development Corp.;

WHEREAS, KXBG Construction and Development Corp./Kenzai Builders Corp./JV was declared as the Lowest Calculated Bidder in the amount of ₱ 114,882,571.84;

WHEREAS, post-qualification was conducted on 09 March 2022 to examine, validate and verify the eligibility, technical and financial requirements submitted by KXBG Construction and Development Corp./Kenzai Builders Corp./JV and in the Post-Qualification Report, as approved by the BAC on 21 March 2022, KXBG Construction and Development Corp./Kenzai Builders Corp./JV was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **KXBG Construction and Development Corp./Kenzai Builders Corp./JV** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Dredging of Currimao Port, Currimao, Ilocos Norte, in the amount of **ONE HUNDRED FOURTEEN MILLION EIGHT HUNDRED EIGHTY TWO THOUSAND FIVE HUNDRED SEVENTY ONE PESOS AND 84/100 (₱ 114,882,571.84)**, inclusive of taxes, to the said bidder.


