Award of Contract PORT TERMINAL MANAGEMENT CONTRACT FOR PORT OF SURIGAO BAC-PTMC-10-2021

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the PTMC for Port of Surigao in The Manila Times, PPA website and in conspicuous places in the PPA premises on 19 October 2021;

WHEREAS, the Minimum Concession Fee for the fifteen (15) year PTMC as posted is Php 667,627,799.33;

WHEREAS, in response to the said advertisement, the Joint Venture of Harbour Centre Port Holdings, Inc. and Globalport Ozamiz Terminal, Inc. (JV HCPHI/GOTI) and Adfil Corporation secured the Bid Documents in the amount of Php 150,000.00;

WHEREAS, during the deadline for submission of bids, JV HCPHI/GOTI dropped its technical and financial bid on time, while Adfil Corporation submitted beyond the deadline; as such, its bid was marked "late" and returned to its representative;

WHEREAS, JV HCPHI/GOTI was declared "passed" with the requirements of the First Envelope during the Opening of Bids on 22 November 2021;

WHEREAS, JV HCPHI/GOTI's Second Envelope was opened and its Proposed Concession Fee was read as follows:

WHEREAS, Post-Qualification was conducted on 9 December 2021 to determine compliance by the JV HCPHI/GOTI with all the requirements, terms and conditions for eligibility and the bidding; and in the Post-Qualification Report, as approved by the BAC-PTMC on 14 December 2021, the proposal of JV HCPHI/GOTI was declared as the Highest Responsive Bid;
