WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery and Installation of Body Scanning Machines (Phase III), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 11 February 2022, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 375,000,000.00**;

WHEREAS, in response to the said advertisement, only Boston Home, Inc. secured the Bid Document in the amount of **₱ 50,000.00** and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 08 March 2022 at 10:00 a.m. Boston Home, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Boston Home, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 10 March 2022 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 11 March 2022, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Boston Home, Inc.;

WHEREAS, Boston Home, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 374,500,000.00;

WHEREAS, post-qualification was conducted on 17 March 2022 to examine, validate and verify the eligibility, technical and financial requirements submitted by Boston Home, Inc. and in the Post-Qualification Report, as approved by the BAC on 24 March 2022, Boston Home, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **BOSTON HOME, INC.** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply, Delivery and Installation of Body Scanning Machines (Phase III), in the amount of **THREE HUNDRED SEVENTY FOUR MILLION FIVE HUNDRED THOUSAND PESOS (PHP 374,500,000.00.00)**, inclusive of taxes, to the said bidder.
