**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
PROCUREMENT OF PEST CONTROL SERVICES FOR PPA HEAD OFFICE,
MOTORPOOL, PPATI, GAD CENTER AND RECORDS STORAGE FACILITY
BAC-PGCS-054-2023**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 17 March 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 2,470,000.00**;

WHEREAS, in response to the said advertisement, only Pest Away Corporation secured the Bid Document in the amount of **₱ 5,000.00** and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 13 April 2023 at 10:00 a.m., the lone bidder, Pest Away Corporation was declared "failed" with the requirements of the First Envelope, for the following reasons:

- a) The Mayor's Permit and Tax Clearance in the Class "A" Eligibility Documents which were an integral part of the Certificate of PhilGEPS Registration expired on June 30, 2022 and February 16, 2023, respectively. The Class "A" Eligibility Documents should remain valid and updated as required in the Certificate of PhilGEPS Registration and GPPB Resolution No. 15-2021.
- b) The Statement of Compliance in the Technical Specifications was not supported by literature (brochure) as required in the Technical Documents.
- c) Failed to comply with the requirement that the Pest Control Operator (PCO) must present Certifications issued by three (3) clients attesting to the services rendered during the last five (5) years. The requirement prescribed in the bidding documents is submission of Certification from three (3) clients.

WHEREAS, Pest Away Corporation signified no intention to file a request for reconsideration, hence its Second Envelope was returned unopened and duly received by its authorized representative;

WHEREAS, considering that the lone bidder was declared "failed", the BAC, after a motion duly made and properly seconded, declared the bidding for the Procurement of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility, a failure, pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, which provides, that:

"35.1 The BAC shall declare the bidding a failure when:

xxx xxx xxx

b) All prospective bidders are declared ineligible;

xxx xxx xxx."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Procurement of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A 9184.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.

This has reference to the Opening of Bids for the Procurement of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility on 13 April 2023, which was declared by the BAC as "failure of bidding," pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: b) All prospective bidders are declared ineligible; xxx xxx xxx."

In view thereof, we are submitting herewith BAC-PGCS Resolution No. 019-2023 Series of 2023, recommending that the bidding for the above project be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
