PROCUREMENT OF SECURITY SERVICES FOR PHILIPPINE PORTS AUTHORITY, PORT SECURITY CLUSTER – SOUTHERN MINDANAO COMPRISING PORT MANAGEMENT OFFICES (PMOS) DAVAO, ZAMBOANGA DEL NORTE, ZAMBOANGA AND SOCSARGEN, AND TERMINAL MANAGEMENT OFFICES (TMOS)/PORTS UNDER THEIR RESPECTIVE JURISDICTION ASD-090-2023

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Security Services for Philippine Ports Authority, Port Security Cluster – Southern Mindanao Comprising Port Management Offices (PMOs) Davao, Zamboanga del Norte, Zamboanga and SOCSARGEN, and Terminal Management Offices (TMOs)/Ports under their respective jurisdiction, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 22 March 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 102,205,332.00**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents in the amount of ₱ 50,000.00 and submitted their Technical and Financial Proposals, namely;

- 1. Sagittarius Security Agency
- 2. Advance Forces Security & Investigation Services, Inc.

WHEREAS, during the opening of bids on 14 April 2023 at 10:00 a.m., Advance Forces Security & Investigation Services, Inc. was declared "passing" with the requirements of the First Envelope. Sagittarius Security Agency was declared "failed" for failure to submit proof of membership of the Philippine Association of Detective and Protective Agency Operators (PADPAO) in good and active standing for the last ten (10) years with issued Certificate of Membership;

WHEREAS, Sagittarius Security Agency signified its intention to file a request for reconsideration on their "failed" rating, hence, their unopened Second Envelopes were retained by the BAC, until their request for reconsideration is resolved by the Committee;

HO-BAC-PGCS Res. No. 031-2023 Page 1 of 3 WHEREAS, the Financial Proposal of Advance Forces Security & Investigation Services, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, on 14 April 2023, Sagittarius Security Agency filed a request for reconsideration on their "failed" rating, however, the BAC, in a meeting held on 24 April 2023, after due deliberation and upon motion duly made and properly seconded, denied said Request for Reconsideration;

WHEREAS, Bid Evaluation was conducted on 02 May 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 03 May 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Advance Forces Security & Investigation Services, Inc.;

WHEREAS, Advance Forces Security & Investigation Services, Inc. was declared as the Single Calculated Bidder in the amount of \$\mathbb{P}\$ 99,044,261.40;

WHEREAS, post-qualification was conducted on 04 May 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Advance Forces Security & Investigation Services, Inc. and in the Post-Qualification Report, as approved by the BAC on 11 May 2023, Advance Forces Security & Investigation Services, Inc. was declared as the Single Calculated and Responsive Bidder:

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare, **ADVANCE FORCES SECURITY & INVESTIGATION SERVICES**, **INC**. as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Procurement of Security Services for Philippine Ports Authority, Port Security Cluster – Southern Mindanao Comprising Port Management Offices (PMOs) Davao, Zamboanga del Norte, Zamboanga and SOCSARGEN, and Terminal Management Offices (TMOs)/Ports under their respective jurisdiction, in the amount of **NINETY NINE MILLION FORTY FOUR THOUSAND TWO HUNDRED SIXTY ONE PESOS AND 40/100 (PHP 99,044,261.40)**, inclusive of taxes, to the said bidder.
