WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Security Services for Philippine Ports Authority, Port Security Cluster - Visayas Comprising Port Management Offices (PMOs) Panay/Guimaras, Negros Oriental/Bacolod/Banago/Bredco, Eastern Leyte/Samar, Western Leyte/Biliran, Bohol, and Negros Occidental/Siquijor, and Terminal Management Offices (TMOs)/Ports under their respective jurisdiction, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 23 March 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 172,606,318.50**;

WHEREAS, in response to the said advertisement, four (4) bidders secured the Bid Documents in the amount of ₱ 50,000.00 and submitted their Technical and Financial Proposals, namely;

1. Lockheed Global Security and Investigation Services, Inc.
2. Vigilant Investigative and Security Agency, Inc.
3. MBZ Security Agency Specialist, Inc.
4. Sagittarius Security Agency

WHEREAS, during the opening of bids on 18 April 2023 at 2:00 p.m., Lockheed Global Security and Investigation Services, Inc. and Sagittarius Security Agency were declared "passing" with the requirements of the First Envelope. MBZ Security Agency Specialist, Inc. and Vigilant Investigative and Security Agency, Inc. were declared "failed" with the requirements of the First Envelope (Technical Proposals);

WHEREAS, MBZ Security Agency Specialist, Inc. signified no intention to file a request for reconsideration on their “failed” rating, hence its Second Envelope was returned unopened and duly received by its authorized representative, while Vigilant Investigative and Security Agency, Inc. declared its intention to file a request for reconsideration, hence the unopened Second Envelopes were retained by the BAC, until the request for reconsideration has been resolved by the Committee;

WHEREAS, the Financial Proposal of Lockheed Global Security and Investigation Services, Inc. and Sagittarius Security Agency were opened and declared “passing” with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, no request for reconsideration was filed by Vigilant Investigation and Security Agency, Inc. within the prescribed deadline for submission thereof, despite its declaration to file such request;

WHEREAS, Bid Evaluation was conducted on 26 April 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 27 April 2023, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Lockheed Global Security and Investigation Services, Inc.;

WHEREAS, deviation was found on the Bid Proposals of Sagittarius Security Agency, and was declared “non-responsive,” and thus, automatically disqualified,” pursuant to Section 32.2.1a of the 2016 Revised IRR of R.A. 9184, which provides, to wit:

*“Completeness of bid. xxx, bids not addressing or providing all of the required items in the Bidding Documents including, where applicable, bill of quantities, shall be considered non-responsive and, thus, automatically disqualified xxx.”*

WHEREAS, Lockheed Global Security and Investigation Services, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 161,298,421.92;

WHEREAS, post-qualification was conducted on 04 May 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Lockheed Global Security and Investigation Services, Inc. and in the Post-Qualification Report, as approved by the BAC on 11 May 2023, Lockheed Global Security and Investigation Services, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **LOCKHEED GLOBAL SECURITY AND INVESTIGATION SERVICES, INC.** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Procurement of Security Services for Philippine Ports Authority, Port Security Cluster - Visayas Comprising Port Management Offices (PMOs) Panay/Guimaras, Negros Oriental/Bacolod/Banago/Bredco, Eastern Leyte/Samar, Western Leyte/Biliran, Bohol, and Negros Occidental/Siquijor, and Terminal Management Offices (TMOs)/Ports under their respective jurisdiction, in the amount of **ONE HUNDRED SIXTY ONE MILLION TWO HUNDRED NINETY EIGHT THOUSAND FOUR HUNDRED TWENTY ONE PESOS AND 92/100 (PHP 161,298,421.92)**, inclusive of taxes, to the said bidder.
