Award of Contract for the
**PROPOSED DREDGING OF THE ENTRANCE CHANNEL AND TURNING BASIN
OF CURRIMAO PORT, CURRIMAO, ILOCOS NORTE**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Proposed Dredging of the Entrance Channel and Turning Basin of Currimao Port, Currimao, Ilocos Norte, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 30 March 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 382,836,347.02**;

WHEREAS, in response to the said advertisement, four (4) bidders secured the Bid Documents in the amount of ₱ 50,000.00 and submitted the Technical and Financial Proposals, namely:

1. MAC Builders
2. Sunwest Incorporated
3. WTG Construction and Development Corporation
4. Hi-Tone Construction and Development Corporation/
Khan Kon Chi Construction & Development Corporation/JV

WHEREAS, during the opening of bids on 25 April 2023 at 2:00 p.m., the four (4) bidders were declared "passing" with the requirements of the First Envelope.

WHEREAS, the Financial Proposals of the four (4) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 02 May 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 03 May 2023, showed discrepancies between the Total Bid Prices and Unit Bid Prices of WTG Construction and Development Corp., and Sunwest, Incorporated, as follows;

WHEREAS, Hi-Tone Construction and Development Corporation/ Khan Kon Chi Construction and Development Corporation/JV was declared as the Lowest Calculated Bidder in the amount of ₱ 381,837,659.46;

WHEREAS, post-qualification was conducted on 09 & 10 May 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by, Hi-Tone Construction and Development Corporation/ Khan Kon Chi Construction and Development Corporation/JV and in the Post-Qualification Report, as approved by the BAC on 15 May 2023, Hi-Tone Construction and Development Corporation/ Khan Kon Chi Construction and Development Corporation/JV was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare, **HI-TONE CONSTRUCTION AND DEVELOPMENT CORPORATION/ KHAN KON CHI CONSTRUCTION AND DEVELOPMENT CORPORATION/JV** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Proposed Dredging of the Entrance Channel and Turning Basin of Currimao Port, Currimao, Ilocos Norte, in the amount of **THREE HUNDRED EIGHTY ONE MILLION EIGHT HUNDRED THIRTY SEVEN THOUSAND SIX HUNDRED FIFTY NINE PESOS AND 46/100 (₱ 381,837,659.46)**, inclusive of taxes, to the said bidder.
