## Award of Contract PORT TERMINAL MANAGEMENT CONTRACT FOR PORT OF PASIG BAC-PTMC-01-2022

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Port Terminal Management Contract (PTMC) for Port of Pasig in The Manila Times, PPA website and in conspicuous places in the PPA premises on 2 April 2022;

WHEREAS, the Minimum Concession Fee for the fifteen (15) year PTMC as posted is Php 2,486,807,087.05, exclusive of all taxes;

WHEREAS, in response to the said advertisement, three (3) bidders secured the Bid Documents in the amount of Php 150,000.00 namely, Mega Equipment International Corporation (MEIC), Manila North Harbour Port, Inc. (MNHPI) and Mega Lifters Cargo Handling Corp (MLCHC);

WHEREAS, MEIC and MNHPI did not submit their technical and financial proposals before the deadline of submission thereof nor did they submit any letter of withdrawal to participate in the bidding;

WHEREAS, during the Opening of Bids on 25 April 2022, MLCHC was declared "passed" with the requirements of the First Envelope;

WHEREAS, the Second Envelope of MLCHC was opened and the proposed Concession Fee was read as follows:

WHEREAS, Bid Evaluation was conducted to determine compliance with the requirements of PPA Administrative Order (AO) No. 12-2018; and the Bid Evaluation Report was approved by the BAC-PTMC on 5 May 2022, declaring MLCHC at its Proposed Concession Fee of Two Billion Four Hundred Ninety Million Pesos (Php 2,490,000,000.00) exclusive of all taxes, as the Bidder with the Highest Concession Fee:

WHEREAS, Post-Qualification was conducted on 12 May 2022 to determine compliance by MLCHC with all the requirements, terms and conditions for eligibility and the bidding; and in the Post-Qualification Report, as approved by the BAC-

PTMC on 23 May 2022, the proposal of MLCHC was declared as the Highest Responsive Bid;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC-PTMC hereby RESOLVE, as it is hereby RESOLVED, to declare MLCHC at its Proposed Concession Fee of Two Billion Four Hundred Ninety Million Pesos (Php 2,490,000,000.00) exclusive of all taxes, as the Highest Responsive Bidder and to recommend the award of Port Terminal Management Contract for Port of Pasig.
