Head Office-Engineering Projects Resolution No. 011-2023 Series of 2023

Award of Contract for the PROPOSED DREDGING OF NORTH HARBOR INNER BASIN PHASE II (FRONTING PIERS 2 TO 12), PORT AREA, MANILA DSD-005-23

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Proposed Dredging of North Harbor Inner Basin Phase II (Fronting Piers 2 to 12), Port Area, Manila in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 30 March 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 341,227,342.53**;

WHEREAS, in response to the said advertisement, five (5) bidders secured the Bid Documents in the amount of ₱ 50,000.00, namely:

- 1. Sunwest Incorporated
- 2. WTG Construction and Development Corporation
- 3. MAC Builders
- 4. Hi-Tone Construction and Development Corporation
- Harbor Star Shipping Services Incorporated/Alphatech PTE LTD/JV

WHEREAS, only four (4) bidders dropped their Technical and Financial Proposals before the prescribed deadline for submission. Harbor Star Shipping Services Incorporated/Alphatech PTE LTD/JV did not submit their Technical and Financial Proposals, nor submitted a letter of withdrawal from participating in the bidding before the prescribed deadline for submission of bid documents;

WHEREAS, during the opening of bids on 26 April 2023 at 10:00 a.m., only three (3) bidders were declared "passing" with the requirements of the First Envelope. Sunwest, Inc. was declared "failed" for non-compliance with the equipment requirements (Self-Propelled Trailing Suction Dredger);

WHEREAS, Sunwest, Inc. signified no intention to file a request for reconsideration on their "failed" rating, hence its Second Envelope was returned unopened and duly received by its authorized representative;

WHEREAS, the Financial Proposals of the three (3) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 02 May 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 03 May 2023, showed discrepancies between the Total Bid Prices and Unit Bid Prices of WTG Construction and Development Corp., Hi-Tone Construction and Development Corp. and MAC Builders, as follows;

WHEREAS, WTG Construction and Development Corp. was declared as the Lowest Calculated Bidder in the amount of ₱ 339,677,749.18;

WHEREAS, post-qualification was conducted on 09 May 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by, WTG Construction and Development Corp. and in the Post-Qualification Report, as approved by the BAC on 15 May 2023, WTG Construction and Development Corp. was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare, WTG CONSTRUCTION AND DEVELOPMENT CORP. as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Proposed Dredging of North Harbor Inner Basin Phase II (Fronting Piers 2 to 12), Port Area, Manila, in the amount of THREE HUNDRED THIRTY NINE MILLION SIX HUNDRED SEVENTY SEVEN THOUSAND SEVEN HUNDRED FORTY NINE PESOS AND 18/100 (\$\mathbf{P}\$ 339,677,749.18), inclusive of taxes, to the said bidder.
