## Award of Contract for the PORT OF CALAPAN IMPROVEMENT PROJECT, PORT OF CALAPAN, ORIENTAL MINDORO

LFP MDO NO. 007-2022

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Port of Calapan Improvement Project, Port of Calapan, Oriental Mindoro, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 11 April 2022, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is ₱ 271,956,324.11;

WHEREAS, in response to the said advertisement, four (4) bidders secured the Bid Documents in the amount of \$\mathbb{P}\$50,000.00 and submitted their Technical and Financial Proposals, namely;

- 1. D.L. Cervantes Construction Corp./Orient Star Construction, Inc./JV
- 2. Vicente T. Lao Construction
- 3. MAC Builders
- 4. Gemma Construction Supply, Inc.

WHEREAS, during the opening of bids on 02 May 2022 at 2:00 p.m., the four (4) bidders were declared "passing" with the requirements of the First Envelope.

WHEREAS, the Financial Proposals of the four (4) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 06 May 2022 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 10 May 2022, showed discrepancies between the Total Bid Prices and Unit Bid Prices of D.L. Cervantes Construction Corp./Orient Star Construction, Inc./JV, as follows;

WHEREAS, deviation was found on the Bid Proposals of Vicente T. Lao Construction, hence was declared "automatically disqualified," pursuant to Section 32.2.1a of the 2016 Revised IRR of R.A. 9184, which provides, to wit:

"Completeness of bid. xxx, bids not addressing or providing all of the required items in the Bidding Documents including, where applicable, bill of quantities, shall be considered non-responsive and, thus, automatically disqualified xxx."

WHEREAS, D.L. Cervantes Construction Corp./Orient Star Construction, Inc./JV was declared as the Lowest Calculated Bidder in the amount of ₱ 270,994,310.84;

WHEREAS, post-qualification was conducted on 17 & 20 May 2022 to examine, validate and verify the eligibility, technical and financial requirements submitted by D.L. Cervantes Construction Corp./Orient Star Construction, Inc./JV and in the Post-Qualification Report, as approved by the BAC on 24 May 2022, D.L. Cervantes Construction Corp./Orient Star Construction, Inc./JV was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **D.L. CERVANTES CONSTRUCTION CORP./ORIENT STAR CONSTRUCTION, INC./JV** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Port of Calapan Improvement Project, Port of Calapan, Oriental Mindoro, in the amount of **TWO HUNDRED SEVENTY MILLION NINE HUNDRED NINETY FOUR THOUSAND THREE HUNDRED TEN PESOS AND 84/100 (P 270,994,310.84),** inclusive of taxes, to the said bidder.
