PROPOSED CONSTRUCTION AND OFFSHORE INSTALLATION OF AIDS TO MARINE NAVIGATION, NORTHWESTERN MINDANAO CLUSTER: PORTS OF ILIGAN, LANAO DEL NORTE; CAGAYAN DE ORO AND OPOL, MISAMIS ORIENTAL; BENONI, BALBAGON AND GUINSILIBAN, CAMIGUIN ISLAND; DAPITAN, SINDANGAN AND LILOY, ZAMBOANGA DEL NORTE DSD-ATON-002-23

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Proposed Construction and Offshore Installation of Aids to Marine Navigation, Northwestern Mindanao Cluster: Ports of Iligan, Lanao Del Norte; Cagayan de Oro and Opol, Misamis Oriental; Benoni, Balbagon and Guinsiliban, Camiguin Island; Dapitan, Sindangan and Liloy, Zamboanga del Norte, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 30 March 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 485,612,705.32**;

WHEREAS, in response to the said advertisement, three (3) bidders secured the Bid Documents in the amount of \$\mathbb{P}\$ 50,000.00 and submitted the Technical and Financial Proposals, namely:

- Jarzoe Builders, Inc./Dalebo Construction and Gen. Merchandise/JV
- 2. MAC Builders
- 3. SB Construction Corp.

WHEREAS, during the opening of bids on 25 April 2023 at 10:00 a.m., only two (2) bidders were declared "passing" with the requirements of the First Envelope, namely: Jarzoe Builders, Inc./Dalebo Construction and Gen. Merchandise/JV and MAC Builders. SB Construction Corp. was declared "failed" for failure to submit pledged Personnel for Materials Engineer II;

WHEREAS, SB Construction Corp. signified no intention to file a request for reconsideration on their "failed" rating, hence its Second Envelope was returned unopened and duly received by its authorized representative;

WHEREAS, the Financial Proposals of the two (2) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 02 May 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 03 May 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Jarzoe Builders, Inc./Dalebo Construction and Gen. Mechandise/JV and MAC Builders;

WHEREAS, Jarzoe Builders, Inc./Dalebo Construction and Gen. Mechandise/JV was declared as the Lowest Calculated Bidder in the amount of ₱ 485,112,156.40;

WHEREAS, post-qualification was conducted on 05 May 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by, Bemkar Construction and in the Post-Qualification Report, as approved by the BAC on 15 May 2023, Jarzoe Builders, Inc./Dalebo Construction and Gen. Mechandise/JV was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare, JARZOE BUILDERS, INC./DALEBO CONSTRUCTION AND GEN. MECHANDISE/JV as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Proposed Construction and Offshore Installation of Aids to Marine Navigation, Northwestern Mindanao Cluster: Ports of Iligan, Lanao Del Norte; Cagayan de Oro and Opol, Misamis Oriental; Benoni, Balbagon and Guinsiliban, Camiguin Island; Dapitan, Sindangan and Liloy, Zamboanga del Norte, in the amount of FOUR HUNDRED EIGHTY FIVE MILLION ONE HUNDRED TWELVE THOUSAND ONE HUNDRED FIFTY SIX PESOS AND 40/100 (P 485,112,156.40), inclusive of taxes, to the said bidder.
