**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE  
DRYDOCKING, REPAIR, AND RE-PAINTING OF MALACAÑANG PONTOON  
LANDING BARGES AND PCG BOAT HOUSE AND CGS LANDING INCLUDING  
REPLACEMENT OF FLOATING BARRIERS  
ASD-146-2023**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Drydocking, Repair, and Re-Painting of Malacañang Pontoon Landing Barges and PCG Boat House and CGS Landing Including Replacement of Floating Barriers, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 18 May 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is ₱ 16,007,987.29;

WHEREAS, in response to the said advertisement, only Remil Sampang Ship Repair Services secured the Bid Document in the amount of ₱ 25,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 13 June 2023 at 10:00 a.m., the lone bidder, Remil Sampang Ship Repair Services was declared "failed" with the requirements of the First Envelope, for the following reasons:

- a. Failed to provide proof that the location of the drydocking, repair and repainting facility is within 30 Km. from Malacañang.
- b. Failed to submit proof of Ownership for the following equipments:
  - i. Five (5) units AC Arc Welding Machine, 300 A
  - ii. Three (3) sets Gas Cutting outfit
  - iii. One (1) Boom Truck (5 ton cap.)
  - iv. One (1) Gen-set, 35 KVA
  - v. Two (2) Service vehicle (4-wheel, gas/diesel)

WHEREAS, Remil Sampang Ship Repair Services signified its intention to file a request for reconsideration, however, on even date, it submitted a letter manifesting that they will no longer file a motion for reconsideration for the project;

WHEREAS, considering that the lone bidder was declared "failed," the BAC declared a failure of bidding, pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, which provides, that:

"35.1 The BAC shall declare the bidding a failure when:

b) All prospective bidders are declared ineligible;


NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:


1. To recommend to the Head of the Procuring Entity that the bidding for the Drydocking, Repair, and Re-Painting of Malacañang Pontoon Landing Barges and PCG Boat House and CGS Landing Including Replacement of Floating Barriers, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.





This has reference to the Opening of Bids for the Drydocking, Repair and Re-Painting of Malacañang Pontoon Landing Barges and PCG Boat House and CGS Landing Including Replacement of Floating Barriers, held on 13 June 2023.
