Head Office-Engineering Projects Resolution No. 015-2022 Series of 2022

Award of Contract for the CONSTRUCTION OF CRUISE SHIP PORT, CORON, PALAWAN LFP PLW NO. 009-2022

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Construction of Cruise Ship Port, Coron, Palawan, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 20 April 2022, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 425,070,501.09**;

WHEREAS, in response to the said advertisement, seven (7) bidders secured the Bid Documents in the amount of ₱ 50,000.00, namely:

- 1. Premium Megastructures, Inc.
- 2. HG-III Construction and Development Corp.
- 3. Sunwest Construction and Development Corp.
- MRBII Construction Corp.
- 5. Hi-Tone Construction and Development Corp.
- 6. WTG Construction and Development Corp.
- 7. MAC Builders

WHEREAS, only five (5) bidders dropped their Technical and Financial Proposals before the prescribed deadline for submission. WTG Construction and Development Corp. and MAC Builders submitted their respective letter of withdrawal from participating in the bidding before the deadline for submission thereof, and the BAC, finding the reasons to be meritorious, accepted their withdrawal from participating in the bidding;

WHEREAS, during the opening of bids on 11 May 2022 at 10:00 a.m., the five (5) bidders were declared "passing" with the requirements of the First Envelope.

WHEREAS, the Financial Proposal of the five (5) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 17 May 2022 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 18 May 2022, showed discrepancies between the Total Bid Prices and Unit Bid Prices of HG-III Construction and Development Corp. and Sunwest Construction and Development Corp., as follows:

WHEREAS, Premium Megastructures, Inc. was declared as the Lowest Calculated Bidder in the amount of ₱ 418,150,000.00;

WHEREAS, post-qualification was conducted on 23-26 May 2022 to examine, validate and verify the eligibility, technical and financial requirements submitted by Premium Megastructures, Inc. and in the Post-Qualification Report, as approved by the BAC on 02 June 2022, Premium Megastructures, Inc. was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **PREMIUM MEGASTRUCTURES, INC.** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Construction of Cruise Ship Port, Coron, Palawan, in the amount of **FOUR HUNDRED EIGHTEEN MILLION ONE HUNDRED FIFTY THOUSAND PESOS** (**P 418,150,000.00**), inclusive of taxes, to the said bidder.
