WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Construction of Wharf and Port Operational Area, Port of San Juan, Batangas, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 20 April 2022, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 148,177,023.91**;

WHEREAS, in response to the said advertisement, four (4) bidders secured the Bid Documents in the amount of ₱50,000.00 and submitted their Technical and Financial Proposals, namely;

- 1. Great Swiss Metal Builders Corporation
- 2. Khan Kon Chi Construction and Development Corporation
- Sunwest Construction and Development Corporation
- 4. Vicente T. Lao Construction

WHEREAS, during the opening of bids on 12 May 2022 at 10:00 a.m., the four (4) bidders were declared "passing" with the requirements of the First Envelope.

WHEREAS, the Financial Proposals of the four (4) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **GREAT SWISS METAL BUILDERS CORPORATION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Construction of Wharf and Port Operational Area, Port of San Juan, Batangas, in the amount of **ONE HUNDRED FORTY FIVE MILLION NINE HUNDRED EIGHTY EIGHT THOUSAND PESOS AND 27/100** (**P 145,988,000.27**), inclusive of taxes, to the said bidder.
