WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Provision of Baggage Security Screening Machine Operators for Philippine Ports Authority Head Office, Port Management Offices and Terminal Management Offices/Ports, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 12 May 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 114,555,931.70**;

WHEREAS, in response to the said advertisement, only Commander Security Services, Inc. secured the Bid Document in the amount of **₱ 50,000.00** and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 02 June 2023 at 10:00 a.m. Commander Security Services, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Commander Security Services, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 07 June 2023 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 09 June 2023, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Commander Security Services, Inc., as follows;

WHEREAS, Commander Security Services, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 111,746,804.76;

WHEREAS, post-qualification was conducted on 14 June 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Commander Security Services, Inc. and in the Post-Qualification Report, as approved by the BAC on 20 June 2023, Commander Security Services, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **COMMANDER SECURITY SERVICES, INC.** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Provision of Baggage Security Screening Machine Operators for Philippine Ports Authority Head Office, Port Management Offices and Terminal Management Offices/Ports, in the amount of **ONE HUNDRED ELEVEN MILLION SEVEN HUNDRED FORTY SIX THOUSAND EIGHT HUNDRED FOUR PESOS AND 76/100 (PHP 111,746,804.76)**, inclusive of taxes, to the said bidder.


