### **RESOLUTION DECLARING FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF MULTI-PURPOSE VEHICLES BAC-PGCS-007-2020**

WHEREAS, the Philippine Ports Authority (PPA) re-posted an Invitation to Bid for the Supply and Delivery of Multi-Purpose Vehicles, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 11 June 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 28,340,000.00**;

WHEREAS, during the scheduled opening of bids on 07 July 2020, there were no bidder/s who secured and submitted the bid documents before the deadline prescribed for submission thereon;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Supply and Delivery of Multi-Purpose Vehicles, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

“35.1 The BAC shall declare the bidding a failure when:

a) No bids are received;

xxx xxx xxx.”

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Supply and Delivery of Multi-Purpose Vehicles, be declared a “failure” pursuant to Section 35.1 (a) of the 2016 Revised IRR of R.A. 9184.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
