Award of Contract for the
**CURRIMAO PORT EXPANSION AND RESTORATION PROJECT,
PORT OF CURRIMAO, CURRIMAO, ILOCOS NORTE**
HO-INFRA-PPDD-23-0001

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Currimao Port Expansion and Restoration Project, Port of Currimao, Currimao, Ilocos, Norte, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 16 June 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 906,832,815.57**;

WHEREAS, in response to the said advertisement, eleven (11) bidders secured the Bid Documents in the amount of **₱ 75,000.00**, namely:

1. Goldridge Construction and Development Corp.
2. Luzviminda Engineering
3. Mamsar Construction and Industrial Corp.
4. Sunwest Incorporated
5. UKC Builders, Inc.
6. Sta. Clara International Corp.
7. HG-III Construction and Development Corporation
8. WTG Construction and Development Corporation
9. MRBII Construction Corporation/KXBG Construction and Development Corporation/JV
10. New San Jose Builders Inc.
11. MAC Builders

WHEREAS, only ten (10) bidders dropped their Technical and Financial Proposals before the deadline for the submission of bid documents on 12 July 2023. Sta. Clara International Corp. did not submit its Technical and Financial Proposals nor submitted a letter of withdrawal from participating in the bidding before the prescribed deadline for submission of bid documents;

WHEREAS, during the opening of bids on 12 July 2023 at 10:00 a.m., only five (5) bidders were declared “passing” with the requirements of the First Envelope, namely: UKC Builders Inc., Goldridge Construction and Development Corp., Sunwest, Inc., WTG Construction and Development Corp. and MRBII Construction Corp./KXBG Construction and Development Corp./JV. MAC Builders was declared “automatically disqualified” for its failure to comply with the bid submission required under Clause 16 of the Bid Data Sheet of the Bidding Documents, which states that “xxx Each bidder shall submit one (1) original and six (6) copies of the Technical and Financial Proposals, properly labelled, book-bound, with hard cover and corresponding index tab.” The submitted original copy of the Technical Proposal has no corresponding index tabs;

WHEREAS, Mamsar Construction and Industrial Corp., Luzviminda Engineering, HG-III Construction and Development Corp., and New San Jose Builders Inc. were declared “failed” for failure to comply with the requirements of the First Envelope (Technical Component);

WHEREAS, Mamsar Construction and Industrial Corp., Luzviminda Engineering, HG-III Construction and Development Corp., and New San Jose Builders Inc. signified their intentions to file a request for reconsideration hence, their Second Envelopes were retained by the BAC until the requests for reconsideration are resolved;

WHEREAS, the Financial Proposals of the five (5) bidders were opened and declared “passing” with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Mamsar Construction and Industrial Corp., Luzviminda Engineering, HG-III Construction and Development Corp., and New San Jose Builders Inc. filed their respective requests for reconsideration on their “failed” rating, and the BAC, in a meeting held on 19 July 2023, after due deliberation, denied the requests for reconsideration;

WHEREAS, Bid Evaluation was conducted on 18 July 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 19 July 2023, showed discrepancies between the Total Bid Prices and Unit Bid Prices of WTG Construction and Development Corporation and Sunwest, Inc., as follows;

WHEREAS, MRBII Construction Corp./KXBG Construction and Development Corp./JV was declared as the Lowest Calculated Bidder in the amount of ₱ 886,698,449.52;

WHEREAS, post-qualification was conducted on 27-28 July 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by MRBII Construction Corp./KXBG Construction and Development Corp./JV and in the Post-Qualification Report, as approved by the BAC on 31 July 2023, MRBII Construction Corp./KXBG Construction and Development Corp./JV was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED, to declare **MRBII CONSTRUCTION CORP./KXBG CONSTRUCTION AND DEVELOPMENT CORP./JV** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Currimao Port Expansion and Restoration Project, Port of Currimao, Currimao, Ilocos, Norte, in the amount of **EIGHT HUNDRED EIGHTY SIX MILLION SIX HUNDRED NINETY EIGHT THOUSAND FOUR HUNDRED FORTY NINE PESOS AND 52/100 (₱ 886,698,449.52)**, inclusive of taxes, to the said bidder.
