WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Additional High Amperage Cables Intended for Twelve (12) Units Generator Sets with Automatic Transfer Switch (ATS) for PMO Mindoro, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 30 June 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 8,500,000.00**;

WHEREAS, in response to the said advertisement, only Mindanao Laboratory Services secured and submitted the Bid Documents;

WHEREAS, during the opening of bids on 21 July 2020 at 10:00 a.m., Mindanao Laboratory Services was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Mindanao Laboratory Services was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 24 July 2020 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 27 July 2020, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Mindanao Laboratory Services;

WHEREAS, Mindanao Laboratory Services was declared as the Single Calculated Bidder in the amount of ₱ 8,490,700.00;


WHEREAS, post-qualification was conducted on 31 July 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by Mindanao Laboratory Services and in the Post-Qualification Report, as approved by the BAC on 03 August 2020, Mindanao Laboratory Services was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **MINDANAO LABORATORY SERVICES** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Supply and Delivery of Additional High Amperage Cables Intended for Twelve (12) Units Generator Sets with Automatic Transfer Switch (ATS) for PMO Mindoro, in the amount of **EIGHT MILLION FOUR HUNDRED NINETY THOUSAND SEVEN HUNDRED PESOS (₱ 8,490,700.00)**, inclusive of taxes, to the said bidder.
