WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Drydocking, Repair, and Re-Painting of Malacañang Pontoon Landing Barges and PCG Boat House and CGS Landing Including Replacement of Floating Barriers, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 23 June 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is ₱ 16,007,987.29;

WHEREAS, in response to the said advertisement, only Remil Sampang Ship Repair Services secured the Bid Document in the amount of ₱ 25,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 18 July 2023 at 10:00 a.m., Remil Sampang Ship Repair Services was declared "passing" with the requirements of the First Envelope:

WHEREAS, the Financial Proposal of Remil Sampang Ship Repair Services was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 20 July 2023 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 25 July 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Remil Sampang Ship Repair Services;

WHEREAS, Remil Sampang Ship Repair Services was declared as the Single Calculated Bidder in the amount of \$\mathbb{P}\$ 15,988,153.79;

WHEREAS, post-qualification was conducted on 31 July 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Remil Sampang Ship Repair Services and in the Post-Qualification Report, as approved by the BAC on 02 August 2023, Remil Sampang Ship Repair Services was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **REMIL SAMPANG SHIP REPAIR SERVICES** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Drydocking, Repair, and Re-Painting of Malacañang Pontoon Landing Barges and PCG Boat House and CGS Landing Including Replacement of Floating Barriers, in the amount of **FIFTEEN MILLION NINE HUNDRED EIGHTY EIGHT THOUSAND ONE HUNDRED FIFTY THREE PESOS AND 79/100 (PHP 15,988,153.79)**, inclusive of taxes, to the said bidder.
