Award of Contract for the  
**PROPOSED DREDGING OF LANAO DEL NORTE CLUSTERED PROJECT:  
PORTS OF ILIGAN, KOLAMBUGAN AND TUBOD**  
*DSD-006-23*

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Proposed Dredging of Lanao Del Norte Clustered Project: Ports of Iligan, Kolambugan and Tubod, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 27 June 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 112,695,786.77**;

WHEREAS, in response to the said advertisement, six (6) bidders secured the Bid Documents in the amount of ₱ 50,000.00 and submitted their Technical and Financial Proposals, namely:

1. Goldridge Construction and Development Corporation
2. JFAP Construction
3. Mamsar Construction and Industrial Corporation
4. Hi-Tone Construction and Development Corporation
5. Khan Kon Chi Construction & Development Corporation
6. MAC Builders

WHEREAS, during the opening of bids on 19 July 2023 at 2:00 p.m., only four (4) bidders were declared "passing" with the requirements of the First Envelope, namely: Goldridge Construction and Development Corp., JFAP Construction, Khan Kon Chi Construction & Development Corp. and MAC Builders. Mamsar Construction and Industrial Corp. and Hi-Tone Construction and Development Corp. were declared "failed" with the requirements of the First Envelope;

WHEREAS, Mamsar Construction and Industrial Corp. failed to comply with the required minimum work experience of the Foreman, similar in nature and complexity to the project to be bid;

WHEREAS, Hi-Tone Construction and Development Corp. submitted the form for the Statement of all on-going government and private contracts, including contracts awarded but not yet started with blank spaces, specifically on the Start of Project date under the column of Contract Duration, which is mandatory and violative, of Sec. 6 of GPBB Resolution No. 16-2020, which provides that: "The Required Forms to be submitted by Bidders shall contain the following:

WHEREAS, Mamsar Construction and Industrial Corp. and Hi-Tone Construction and Development Corp. signified their intentions to file a request for reconsideration hence, their Second Envelopes were retained by the BAC until the requests for reconsideration are resolved;

WHEREAS, the Financial Proposals of the four (4) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Hi-Tone Construction and Development Corp. submitted a letter, dated July 21, 2023, informing the BAC that they will no longer file a request for reconsideration, while Mamsar Construction and Industrial Corp. did not file a request for reconsideration within the prescribed deadline for submission thereof;



WHEREAS, Bid Evaluation was conducted on 25 July 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 26 July 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices;

WHEREAS, Goldridge Construction and Development Corp. was declared as the Lowest Calculated Bidder in the amount of ₱ 111,494,806.24;

WHEREAS, post-qualification was conducted on 28 July 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by, Goldridge Construction and Development Corp. and in the Post-Qualification Report, as approved by the BAC on 01 August 2023, Goldridge Construction and Development Corp. was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare, **GOLDRIDGE CONSTRUCTION AND DEVELOPMENT CORP.** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Proposed Dredging of Lanao Del Norte Clustered Project: Ports of Iligan, Kolambugan and Tubod, in the amount of **ONE HUNDRED ELEVEN MILLION FOUR HUNDRED NINETY FOUR THOUSAND EIGHT HUNDRED SIX PESOS AND 24/100 (₱ 111,494,806.24)**, inclusive of taxes, to the said bidder.
