RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PROCUREMENT OF AERIAL LIDAR (LIGHT DETECTION AND RANGING)/LASER SCANNER TECHNOLOGY INTEGRATED WITH UNMANNED AERIAL VEHICLE (UAV) ASD-144-2023

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Aerial LiDaR (Light Detection and Ranging)/Laser Scanner Technology Integrated with Unmanned Aerial Vehicle (UAV), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 27 June 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **? 24,000,000.00**;

WHEREAS, in response to the said advertisement, only Rasa Surveying Instruments secured the Bid Document in the amount of \$\mathbb{P}\$ 25,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 19 July 2023 at 10:00 a.m., the lone bidder, RASA Surveying Instruments was declared "passed" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of RASA Surveying Instruments was opened, and the financial bid was read by the Chairperson, as follows:

WHEREAS, the lone bidder failed to comply with the requirements of the Second Envelope when they submitted the form "Price Schedule for Goods Offered from within the Philippines" instead of the form "Price Schedule for Goods Offered from Abroad," notwithstanding their declaration that the origin of goods being offered is from Sweden. GPPB Non-Policy Matter (NPM) No. 058-2015 dated October 9, 2015, provides that, "xxx For bidders offering imported products, the form to be used by the bidder shall be the Price Schedule for Goods Offered from Abroad xxx":

WHEREAS, RASA Surveying Instruments was declared "failed" and signified their intention to file a request for reconsideration;

WHEREAS, RASA Surveying Instruments, filed an undated Motion for Reconsideration on their "failed" rating, which was within the prescribed deadline for filing thereof, however, the BAC, in a meeting held on 02 August 2023, after due deliberation and upon motion duly made and properly seconded, denied said Motion for Reconsideration:

WHEREAS, considering that the lone bidder was declared "failed," the BAC declared a failure of bidding, pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, which provides, that:

*35.1 The BAC shall declare the bidding a failure when:

b) All prospective bidders are declared ineligible;

XXX XXX XXX."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

- To recommend to the Head of the Procuring Entity that the bidding for the Procurement of Aerial LiDaR (Light Detection and Ranging)/Laser Scanner Technology Integrated with Unmanned Aerial Vehicle (UAV), be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A 9184.
- 2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.

SUBJECT : Resolution Declaring Failure of Bidding for the Procurement

of Aerial Lidar (Light Detection and Ranging)/Laser Scanner Technology Integrated with Unmanned Aerial Vehicle (UAV)

This has reference to the Opening of Bids for the Procurement of Aerial Lidar (Light Detection and Ranging)/Laser Scanner Technology Integrated with Unmanned Aerial Vehicle (UAV), held on 19 July 2023, which was declared by the BAC as "failure of bidding," pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: b) All prospective bidders are declared ineligible xxx xxx xxx." The lone bidder RASA Surveying Instruments was declared "failed" for failure to submit the required form for the Price Schedule for Goods Offered from Abroad."

In view thereof, we are submitting herewith BAC-PGCS Resolution 060-2023 Series of 2023, recommending that the bidding for the above project be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with readvertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity:
