WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Lipata Port Rehabilitation Project, Port of Lipata, Surigao del Norte, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 16 June 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 59,227,708.38**;

WHEREAS, in response to the said advertisement, four (4) bidders secured the Bid Documents in the amount of \$\bigsip\$ 50,000.00 and submitted their Technical and Financial Proposals, namely:

- 1. LAJ Trucking and Builders Incorporated
- 2. Vicente T. Lao Construction
- 3. Equi-Parco Construction Co.
- UKC Builders, Inc./Evenpar Construction and Development Corp./JV

WHEREAS, during the opening of bids on 13 July 2023 at 10:00 a.m., the four (4) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposals of the four (4) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 18 July 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 19 July 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices:

WHEREAS, LAJ Trucking and Builders Inc. was declared as the Lowest Calculated Bidder in the amount of ₱ 58,386,679.93;

WHEREAS, post-qualification was conducted on 24-25 July 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by LAJ Trucking and Builders Inc. and in the Post-Qualification Report, as approved by the BAC on 31 July 2023, LAJ Trucking and Builders Inc. was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare, LAJ TRUCKING AND BUILDERS INC. as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Lipata Port Rehabilitation Project, Port of Lipata, Surigao del Norte, in the amount of FIFTY EIGHT MILLION THREE HUNDRED EIGHTY SIX THOUSAND SIX HUNDRED SEVENTY NINE PESOS AND 93/100 (₱ 58,386,679.93), inclusive of taxes, to the said bidder.
