Award of Contract for the PROPOSED DREDGING OF SURIGAO CLUSTERED PROJECT: PORTS OF SURIGAO, SURIGAO DEL NORTE AND DEL CARMEN, SIARGAO ISLAND DSD-008-23

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Proposed Dredging of Surigao Clustered Project: Ports of Surigao, Surigao del Norte and Del Carmen, Siargao Island, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 27 June 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is ₱ 187,749,751.78;

WHEREAS, in response to the said advertisement, five (5) bidders secured the Bid Documents in the amount of ₱ 50,000.00 and submitted their Technical and Financial Proposals, namely:

- 1. MAC Builders
- 2. Sunwest, Inc.
- 3. Hi-Tone Construction and Development Corporation
- 4. Khan Kon Chi Construction & Development Corporation
- 5. JFAP Construction

WHEREAS, during the opening of bids on 21 July 2023 at 10:00 a.m., the five (5) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposals of the five (5) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 25 July 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 26 July 2023, showed discrepancies between the Total Bid Prices and Unit Bid Prices Sunwest, Inc. and Hi-Tone Construction and Development Corporation, as follows;

WHEREAS, JFAP Construction was declared as the Lowest Calculated Bidder in the amount of ₱ 186,538,949.67;

WHEREAS, post-qualification was conducted on 28 July 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by, JFAP Construction and in the Post-Qualification Report, as approved by the BAC on 01 August 2023, JFAP Construction was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare, **JFAP CONSTRUCTION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Proposed Dredging of Surigao Clustered Project: Ports of Surigao, Surigao del Norte and Del Carmen, Siargao Island, in the amount of **ONE HUNDRED EIGHTY SIX MILLION FIVE HUNDRED THIRTY EIGHT THOUSAND NINE HUNDRED FORTY NINE PESOS AND 67/100 (₱ 186,538,949.67)**, inclusive of taxes, to the said bidder.
