WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Construction of RoRo Ramp and RC Pier Extension, Mandaon Port, Mandaon, Masbate, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 03 June 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 109,869,661.78**;

WHEREAS, in response to the said advertisement, three (3) bidders secured the Bid Documents in the amount of **₱ 50,000.00** and submitted their Technical and Financial Proposals, namely:

1. Khan Kon Chi Construction and Development Corporation
2. Vicente T. Lao Construction
3. Premium Megastructures Incorporated

WHEREAS, during the opening of bids on 29 June 2021 at 10:00 a.m., the three (3) bidders were declared "passing" with the requirements of the First Envelope.

WHEREAS, the Financial Proposal of the three (3) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 05 July 2021 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 06 July 2021, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of the three (3) bidders;


WHEREAS, Premium Megastructures Incorporated was declared as the Lowest Calculated Bidder in the amount of ₱ 108,889,860.11;

WHEREAS, post-qualification was conducted on 19 July 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by Premium Megastructures Incorporated and in the Post-Qualification Report, as approved by the BAC on 20 August 2021, Premium Megastructures Incorporated was declared as the Lowest Calculated and Responsive Bidder;




