Award of Contract for the LOOC PORT (MALBOG) IMPROVEMENT PROJECT, PORT OF LOOC, BRGY. MALBOG, LOOC, ROMBLON HO-INFRA-PPDD-23-0022

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Looc Port (Malbog) Improvement Project, Port of Looc, Brgy. Malbog, Looc, Romblon, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 05 August 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **35,784,363.43**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents in the amount of ₱ 25,000.00 and submitted their Technical and Financial Proposals, namely:

- Vesa Engineering and Construction/ S2A Builders Corporation/JV
- 2. Orientech Construction and Development Corporation

WHEREAS, during the opening of bids on 05 September 2023 at 9:00 a.m., only Vesa Engineering and Construction/S2A Builders Corporation/JV was declared "passing" with the requirements of the First Envelope. Orientech Construction and Development Corporation was declared "failed" for the following reasons:

- Failed to submit LTO Official Receipt and Certificate of Registration for the one (1) Transit Mixer (lease).
- b. Failed to submit Deed of Sale for one (1) unit Dump Truck (owned) and it is not in the name of the company.

WHEREAS, Orientech Construction and Development Corporation signified no intention to file a request for reconsideration hence, their Second Envelope was returned unopened and duly received by their authorized representative;

WHEREAS, the Financial Proposal of Vesa Engineering and Construction/S2A Builders Corporation/JV was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 11 September 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 13 September 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices;

WHEREAS, Vesa Engineering and Construction/S2A Builders Corporation/JV was declared as the Single Calculated Bidder in the amount of ₱ 35,405,565.01;

WHEREAS, post-qualification was conducted on 15 & 16 September 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Vesa Engineering and Construction/S2A Builders Corporation/JV and in the Post-Qualification Report, as approved by the BAC on 19 September 2023, Vesa Engineering and Construction/S2A Builders Corporation/JV was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED, to declare **VESA ENGINEERING AND CONSTRUCTION/S2A BUILDERS CORPORATION/JV** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Looc Port (Malbog) Improvement Project, Port of Looc, Brgy. Malbog, Looc, Romblon, in the amount of **THIRTY FIVE MILLION FOUR HUNDRED FIVE THOUSAND FIVE HUNDRED SIXTY FIVE PESOS AND 01/100 (₱ 35,405,565.01)**, inclusive of taxes, to the said bidder.
