Award of Contract for the PROCUREMENT OF A HIGH QUALITY RTK GNSS RECEIVER ASD-145-2023

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of a High Quality RTK GNSS Receiver, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 10 August 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is ₱ 2,000,000.00;

WHEREAS, in response to the said advertisement, only RASA Surveying Instruments secured the Bid Document in the amount of ₱ 5,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 12 September 2023 at 10:00 a.m., RASA Surveying Instruments was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of RASA Surveying Instruments was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 18 September 2023 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 19 September 2023, showed discrepancies under Column No. 6 Total CIF or CIP Price Per Item of the Price Schedule, as follows:

WHEREAS, considering that there were other factors in computing the total bid price, computation errors found under Column No. 6 Total CIF or CIP Price Per Item of the Price Schedule did not affect the total bid price of RASA Surveying Instruments;

WHEREAS, RASA Surveying Instruments was declared as the Single Calculated Bidder in the amount of ₱ 1,988,988.00;

WHEREAS, post-qualification was conducted on 27 September 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by RASA Surveying Instruments and in the Post-Qualification Report, as approved by the BAC on 03 October 2023, RASA Surveying Instruments was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare RASA SURVEYING **INSTRUMENTS** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Procurement of a High Quality RTK GNSS Receiver, in the amount of ONE MILLION NINE HUNDRED EIGHTY EIGHT THOUSAND NINE HUNDRED EIGHTY EIGHT PESOS (PHP 1,988,988.00), inclusive of taxes, to the said bidder.
