### **RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PROPOSED DREDGING OF ILOILO RIVER WHARF ILOILO CITY, PANAY ISLAND LFP PNG No. 040-2019**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Proposed Dredging of Iloilo River Wharf, Iloilo City, Panay Island, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 19 November 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be bid as posted/advertised is **₱ 236,462,412.55**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents, namely: Hi-Tone Const. & Dev't. Corp./Khan Kon Chi Const. and Dev't. Corp./JV and WTG Const. Const. & Dev't. Corp.;

WHEREAS, Hi-Tone Const. & Dev't. Corp./Khan Kon Chi Const. and Dev't. Corp./JV submitted its bid documents at 1:15 p.m. or after the prescribed deadline of 1:00 p.m. on 16 December 2019, hence the same were not accepted by the BAC Secretariat, pursuant to the 2016 Revised IRR of R.A. 9184 on late submission of bids, while WTG Const. Const. & Dev't. Corp. did not submit their bid documents nor did they submit a letter of withdrawal from participating in the bidding before the deadline for submission of bids;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Proposed Dredging of Iloilo River Wharf, Iloilo City, Panay Island, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

**"35.1 The BAC shall declare the bidding a failure when:**

**a) No bids are received;**

**xxx xxx xxx."**

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Proposed Dredging of Iloilo River Wharf, Iloilo City, Panay Island, be declared a "failure" pursuant to Section 35.1 (a) of the 2016 Revised IRR of R.A. 9184.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.


