

BAC RESOLUTION OF AWARD

Resolution No. BAC-NCR South-10-18 Series of 2018

WHEREAS, the PMO-NCR South Bids and Awards Committee (BAC-NCR South) convened on 12 December 2018, 2:00 P.M. at the Conference Room, 2nd floor, PMO-NCR South to conduct a Public Bidding as mandated by the Implementing Rules and Regulations (IRR-A) of RA 9184 for the project "Asphalt overlaying at 11th, 13th, 25th and Railroad Sts., South Harbor, Port Area, Manila" (PMO-NCR South-A180171);

WHEREAS, the Bid Proposal of the bidder, FEL-GENE CONSTRUCTION was opened in public to determine the Bidder's compliance with the required documents;

WHEREAS, the first envelope containing the Technical Proposal and the second envelope containing the Financial Proposal of FEL-GENE CONSTRUCTION were opened and found to have complied with the requirements and was rated and declared "PASSED";

WHEREAS, the bid price of FEL-GENE CONSTRUCTION in the amount of *Eleven Million Five Hundred One Thousand Eighty Three Pesos and 22/100 (PhP 11,501,083.22)* is below the Approved Budget for the Contract (ABC) in the amount of Eleven Million Five Hundred Thirty One Thousand Three Hundred Forty One Pesos and 41/100 (PhP 11,531,341.41);

WHEREAS, upon post-qualification and after careful examination, validation and verification of all the technical and financial requirements submitted to the BAC by the bidder with the Single Calculated Bid (SCB), the bidder, **FEL-GENE CONSTRUCTION** passed the required post-qualification, and therefore, was determined as the Single Calculated Responsive Bidder (SCRB) considered for award of the contract.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee (BAC), hereby RESOLVED as it is hereby RESOLVED:

- a. To declare FEL-GENE CONSTRUCTION as the Bidder with the Single Calculated Responsive Bid (SCRB) for the project ASPHALT OVERLAYING AT 11TH, 13TH, 25TH AND RAILROAD STS., SOUTH HARBOR, PORT AREA, MANILA.
- b. To award the Contract to FEL-GENE CONSTRUCTION as the bidder with the Single Calculated Responsive Bid (SCRB) in the amount of ELEVEN MILLION FIVE HUNDRED ONE THOUSAND EIGHTY THREE PESOS AND 22/100 (PhP 11,501,083.22), subject to existing rules and regulations.
