RESOLUTION NO. 01-2021

RESOLUTION DECLARING FAILURE OF BIDDING

WHEREAS, the PMO-NCR North Bids and Awards Committee (PMO-NCR-NORTH-BAC) advertised the Invitation to Bid for the Project "Construction and Installation of Steel Gates, Guardhouse, Car Barrier and Concrete Barrier Separator at Isla Puting Bato/ICX Roadway" at PHILGEPS and PPA Websites, and at conspicuous places at PPA Offices in Manila continuously for the period September 23 to October 11, 2021;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder purchased and secured the corresponding Bid Documents, namely:

1. MR Palabao Construction and Supplies

WHEREAS, on October 11, 2021 at 10:00 A.M., during the opening of bids of the first envelope containing the eligibility and technical proposals submitted by MR Palabao Construction and Supplies, the BAC-TWG recommended to the Committee that the first envelope be declared as "**Failed**" for the following reasons:

A. Eligibility Documents

- 2.2 No statement of the bidder's SLCC similar to be bid
- 2.3 No stated experience record on Similarly Completed Projects

B. Technical Documents

2. Project Requirements:
 - b. No Material's Engineer personnel listed
 - d. Non-compliance on major equipment

WHEREAS, on motion duly moved and seconded, the first envelope containing the eligibility and technical proposals submitted by MR Palabao Construction and Supplies were declared as "**Failed**" by the Committee;

WHEREAS, the second envelope containing the financial proposal was returned to the said contractor unopened, while the first envelope containing the eligibility and technical proposals were retained in the possession of the Committee for record purposes.

NOW, THEREFORE, for and consideration of the foregoing premises, the PMO-NCR-NORTH-BAC RESOLVES, as it is hereby RESOLVED as follows:

1. To recommend to the Port Manager, PMO-NCR North, that the bidding for the project "Construction and Installation of Steel Gates, Guardhouse, Car Barrier and Concrete Barrier Separator at Isla Puting Bato/ICX Roadway" be declared a "FAILURE", pursuant to Section 35.1 (c) of the revised IRR of R.A. 9184.
2. To conduct a re-bidding with re-advertisement and/or re-posting, as provided for in Section 21.2 of the revised IRR of R.A. 9184.
