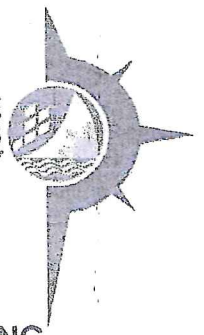

**BAC RESOLUTION DECLARING FAILURE OF BIDDING AND RECOMMENDING APPROVAL**

ONE (1) LOT SUPPLY OF MATERIALS, AND EQUIPMENT FOR THE PROCUREMENT OF VARIOUS CARPENTRY TOOLS FOR THE PREVENTIVE MAINTENANCE OF PORT FACILITIES, PORT OF ZAMBOANGA, ZAMBOANGA CITY WITH AN ABC OF PHP225,950.76

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the ONE (1) LOT SUPPLY OF MATERIALS, AND EQUIPMENT FOR THE PROCUREMENT OF VARIOUS CARPENTRY TOOLS FOR THE PREVENTIVE MAINTENANCE OF PORT FACILITIES, PORT OF ZAMBOANGA, ZAMBOANGA CITY WITH AN ABC OF PHP225,950.76 on December 18 to 25, 2023, in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC sent Request for Quotation (RFQ) to three (3) suppliers, namely: Asiatic Trading Corp.; Dennis Hardware Enterprise, Inc., and Nationwide Sales Corp.;

WHEREAS, the BAC opened the sealed price quotation of supplier on December 27, 2023, at 10:00AM. There was no sealed envelope received from the supplier;

NOW THEREFORE, We, the Members of the PMO Zamboanga Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

To declare the procurement of ONE (1) LOT SUPPLY OF MATERIALS, AND EQUIPMENT FOR THE PROCUREMENT OF VARIOUS CARPENTRY TOOLS FOR THE PREVENTIVE MAINTENANCE OF PORT FACILITIES, PORT OF ZAMBOANGA, ZAMBOANGA CITY WITH AN ABC OF PHP225,950.76 as Failure of Bidding since there were no interested supplier and that the target date for the posting of the Request for Quotation (RFQs) is on January 3, 2024 to January 10, 2024 and the opening of price quotation envelope is on January 11, 2024.
