WHEREAS, pursuant to Resolution No. A001-2025(G), the Philippine Ports Authority, PMO Batangas (PPA-PMOB), through its Bids and Awards Committee (PMOB-BAC), had undertaken procurement of the project **PERIODIC MAINTENANCE SERVICE (PMS) CHECK-UP OF TOYOTA SUPER GRANDIA WITH PLATE NO. DAT 7142** through **Direct Contracting** in accordance with Section 50 of the 2016 Revised IRR of RA 9184;

WHEREAS, in response to said RFQ, **TOYOTA BATANGAS CITY, INC.** submitted pertinent bid documents notably Mayor's Permit, PHILGEPS Registration, Certification for Authorized/Official Service Provider and its proposed cost for the project;

WHEREAS, the quoted amount submitted is **THIRTY FOUR THOUSAND SIX HUNDRED FIFTY FIVE PESOS AND 56/100 (PHP 34,655.56), PHILIPPINE CURRENCY**;

WHEREAS, the PMOB-BAC finds the proposed cost reasonable;

NOW, THEREFORE, for and in consideration of the foregoing, the PMOB-BAC hereby resolves, as it is hereby resolved, to recommend to the PPA-PMOB Port Manager, the award of contract/purchase order for the aforementioned project in favor of **TOYOTA BATANGAS CITY, INC.** in the amount of **THIRTY FOUR THOUSAND SIX HUNDRED FIFTY FIVE PESOS AND 56/100 (PHP 34,655.56), PHILIPPINE CURRENCY**, in accordance with Section 50, **Direct Contracting**, of the 2016 Revised IRR of RA 9184.
