**WHEREAS**, the Approved Budget for the Contract (ABC) for the aforementioned project is **FIFTY THOUSAND PESOS (Php 50,000.00)**, **PHILIPPINE CURRENCY** as per Purchase Request (PR) No. **BAT-1616-26** dated **27 February 2026**;

**WHEREAS**, the applicable Request for Quotation (RFQ) for the aforesaid procurement was prepared;

**WHEREAS**, applicable Request for Quotation (RFQ) was posted on the PPA Website and the PMOB Bulletin Board;

**WHEREAS**, the aforesaid RFQ was likewise distributed to local suppliers;

**WHEREAS**, in response to said RFQ, **MANNAPRINTS TRADING** (through electronic mail) and **GIGAPRINT PRINTING SERVICES** submitted its bid/quotation before the deadline of **9:00 am, 11 March 2026**;

**WHEREAS**, upon examination of the submitted documents, **GIGAPRINT PRINTING SERVICES** was found to be the only bidder compliant with the requirements and its quotation was determined as follows:
