



RESOLUTION No. C001-2026(G)
PMO BATANGAS BIDS AND AWARDS COMMITTEE
(PMOB-BAC)

WHEREAS, pursuant to Resolution No. B004-2026(G), the PMOB-BAC recommended to the Port Manager the rebidding of the project **Repair and Replacement of Defective Parts of Passenger Elevators** through **Direct Contracting** in accordance with Section 31 of the Implementing Rules and Regulations of Republic Act No. 12009, and was approved;

WHEREAS, the Approved Budget for the Contract (ABC) for the aforementioned project in the amount of **SEVEN HUNDRED TWENTY TWO THOUSAND SIXTY FOUR PESOS (Php 722,064.00)**, **PHILIPPINE CURRENCY** as per Purchase Request (PR) No. **BAT-1611-26** dated **16 February 2026**;

WHEREAS, the applicable Request for Quotation (RFQ) was posted in the PPA website and PMOB Bulletin Board;

WHEREAS, PPA-PMOB had requested **INTERNATIONAL ELEVATOR & EQUIPMENT, INC.**, the sole distributor of Mitsubishi Elevators and with exclusive authority and technical capability to render services and maintenance on Mitsubishi elevators, to submit a proposal for the aforementioned project in order to guarantee the safety of its users and to ensure their safe and proper function;

WHEREAS, in response to said RFQ, **INTERNATIONAL ELEVATOR & EQUIPMENT, INC.** submitted pertinent bid documents notably Mayor's Permit, PHILGEPS Registration, Income and Business Tax Return, Certification for Sole/Exclusive Distributorship, duly conformed Terms of Reference and its proposed cost for the project;

WHEREAS, during examination of the documents, it was found that the documents submitted by **INTERNATIONAL ELEVATOR & EQUIPMENT, INC.** were found compliant with the requirements and its quotation was determined as follows:

NOW, THEREFORE, for and in consideration of the foregoing, the PMOB-BAC hereby resolves, as it is hereby resolved, to recommend to the PPA-PMOB Port Manager, the award of contract/purchase order for the project **REPAIR AND REPLACEMENT OF DEFECTIVE PARTS OF PASSENGER ELEVATORS** in favor of **INTERNATIONAL ELEVATOR & EQUIPMENT, INC.** in the amount of **SEVEN HUNDRED TWENTY TWO THOUSAND SIXTY FOUR PESOS (Php 722,064.00)**, **PHILIPPINE CURRENCY**, through **Direct Contracting** in accordance with Section 31 of the Implementing Rules and Regulations of Republic Act No. 12009.
