WHEREAS, pursuant to Resolution No. B005-2026(G), the PMOB-BAC recommended to the Port Manager the rebidding of the project **Supply and Delivery of Purified Drinking Water for PMO Batangas** through **Small Value Procurement** in accordance with Section 34 of the Implementing Rules and Regulations of Republic Act No. 12009, and was approved;

WHEREAS, the Approved Budget for the Contract (ABC) for the aforementioned project in the amount of **TWO HUNDRED FORTY TWO THOUSAND PESOS (Php 242,000.00)**, **PHILIPPINE CURRENCY** as per Purchase Request (PR) No. **BAT-1613-26** dated **24 February 2026**;

WHEREAS, the applicable Request for Quotation (RFQ) for the aforesaid procurement was prepared;

WHEREAS, applicable Request for Quotation (RFQ) was posted in the PhilGEPS, PPA Website and PMOB Bulletin Board;

WHEREAS, the aforesaid RFQ was likewise distributed to local suppliers;

WHEREAS, in response to said RFQ, only **TUBIG ANGEL WATER REFILLING STATION** submitted its bid/quotation before the deadline of **9:00 am, 17 March 2026**;

WHEREAS, during examination of the documents, it was found that the documents submitted by **TUBIG ANGEL WATER REFILLING STATION** were found compliant with the requirements and its quotation was determined as follow:

WHEREAS, as per Post Qualification Report dated 18 March 2026 it was determined that the bid of **TUBIG ANGEL WATER REFILLING STATION** is responsive to the requirements and therefore declared as the single calculated and responsive quotation;

NOW, THEREFORE, for and in consideration of the foregoing, and to promote economy and efficiency in the procurement, the PMO Batangas Bids and Awards Committee (PMOB-BAC) hereby resolves, as it is hereby resolved, to respectfully recommend to the PPA-PMOB Port Manager, the award of contract/Purchase Order to **TUBIG ANGEL WATER REFILLING STATION** as the single calculated and responsive quotation for the project **SUPPLY AND DELIVERY OF PURIFIED DRINKING WATER FOR PMO BATANGAS** in the amount of **TWO HUNDRED ELEVEN THOUSAND SEVEN HUNDRED FIFTY PESOS (Php 211,750.00)**, **PHILIPPINE CURRENCY**.
